- PARTICIPATION IN A CLIMATE CHANGE AGREEMENT WITH THE GOVERNMENT MAY BE NECESSARY

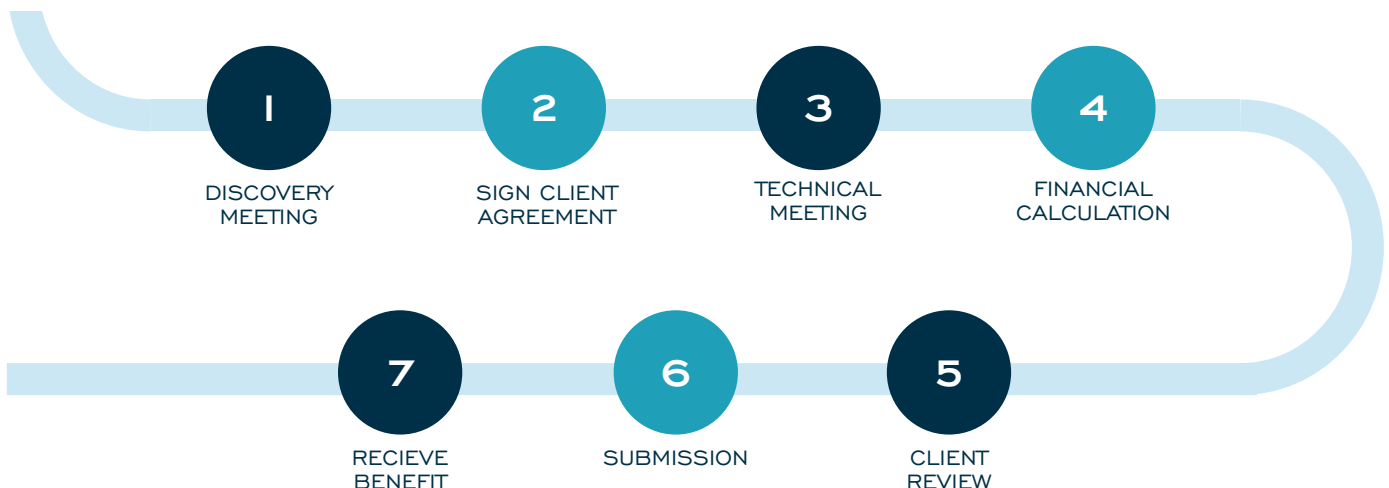

## CASE STUDY 1 :



IRONCLAD STEEL INC., A PROMINENT STEEL MANUFACTURING COMPANY, WAS GRAPPLING WITH ESCALATING COSTS DUE TO THE CLIMATE CHANGE LEVY. THIS ALLOWED FOR INVESTMENT IN ADVANCED, ENERGY-EFFICIENT MACHINERY THAT SLASHED ENERGY CONSUMPTION BY 25%.
